- Leave GAME ID, Custom Game ID, Partner Blank
- All matches require TSSAA registered officials
- Return as Excel attachment/NO google docx, no Apple product
- <u>Schedules Due by July 25/Aug 1 \$25 late fee assessed</u>
- 2. Invitational Tournaments:
 - Submit dates ONLY asap
 - Submit on **separate CAVOA SSF**, listing each court and match/14 days prior to tourney
 - Participating teams MUST provide scorer, tracker, or timer & one ADULT line judge/No support personnel? NO PLAY
 - Do not know opponents? List TBA.
 - Site (home team) &sub site (court#--only if using multiple courts)
 - Home Team is Bill To & pays ALL officials fees.
- 3. <u>CAVOA Change Form</u>: On Arbiter Sports & CAVOA.org under FORMS.
 - Title "For Coaches: How Do I Change My Schedule?"
 - Add, Delete, or Change Dates of matches.

- Please check Arbiter regularly for dates, times, and officials' names and allow <u>48 HOURS FOR CHANGES!</u>
- Do NOT use CAVOA SSF to change matches—all changes on CAVOA Change Forms. (SSF only for original schedule submission)

4. TIME CHANGES only? Contact officials directly and change times based on availability of officials. These changes do NOT have to be submitted to assigners!

5. Who are my OFFICIALS? ALL matches will be posted on Arbiter Sports.

- Home Team pays officials on site or through Arbiter Pay for all matches
- Assigner fees computed individually by schedule/ALL schools will receive invoice for Assigner Fee/must be paid within 14 days to avoid late fee

6. HOW DO I ADD ASSISTANT COACHES, A.D., AND BOOKKEEPERS to Arbiter Sports? Send me a name, title, school, and e-mail address.

7. When you **sign into** Arbiter Sports, sign in under group **CAVOA** (**Chattanooga Area Volleyball Officials Association**).

8. <u>When all schedules have been submitted and entered in Arbiter</u>, sign in and confirm your schedules. It is vital that you sign in and confirm your schedule by e-mail to KELLIE *prior to the beginning of the season*. Check regularly for changes.

9. Responsibility of the HOME team/regular season matches:

- Furnish scorer, libero tracker, timer, and two adult line judges for Varsity matches.
- The scorer may NOT be libero tracker.
- NFHS requires flags, furnished by the HOME site.
- Sub-varsity (6^{th, 7th}, 9^{th, grade}) matches do not require adult line judges but are strongly encouraged.
- All assistant officials should be professionally trained prior to the match. VOLLEYWRITE users must provide libero tracker if either team is using libero.
